


U of I president search

Dear Board,

I received the announcement about the final candidate a short time ago. While I have no illusions that my opinion carries any weight, I do want to register my distress at the selection of someone, however accomplished in business, has no PhD and relatively little academic or university leadership experience. I also suspect, given the compressed schedule for selection following interviews, that his appearance as the fourth candidate has less to do with chance and scheduling conflicts than it does with "strategy."

While I fear you regard the idea with something like contempt, I imagine it likely that the choice may diminish the University's (and by extension, the State's) prestige in very material ways. There is little in his background to demonstrate any particular talent in terms of pedagogy. Yes, he has taught, but his achievements are clearly within a business context. While I've seen no recent evidence to suggest you believe it, an R1 institution is not a business for some very good reasons. I can understand the appeal (and value) of business acumen. I would hope to see it in tandem with the heart of a teacher.

It is probably too late to contact you about the president of the University of Iowa position. Three of the four candidates are highly qualified. While J. Bruce Harreld is probably a great businessman he has absolutely none of the qualifications needed to run the University of Iowa. While I was shocked to read about his selection in the Gazette I was hoping that he would impress me at the forum. I went from shocked at his selection as one of the top for to devastated at the prospects of his selection as Iowa's next president.

It is bad enough he doesn't have the normal academic credentials, but I would expect any business leader applying for a job to come to the interview prepared and knowledgeable on the institution he wants to run. He was totally unprepared, and repeatedly admitted in his opening before the Q & A that he didn't know about this area or that. It was apparent his knowledge of UI came from Wikipedia. 

This is Ben Gillig - I was president of the University of Iowa Graduate and Professional Student Government during the 2013-2014 year when we worked together to implement the tuition freeze and secure state funding for the new pharmacy building.

I am writing for two reasons. First, I want to thank you for the unprecedented involvement students have had in selecting and interviewing the finalists for the UI presidency - we deeply appreciate the opportunity to add our voices to the deliberations.

Second, I want to express an opinion: the Board of Regents should select Joseph Steinmetz as the next UI President. Dr. Steinmetz had far and away the most comprehensive vision for what the university can become, and the best plan for how to get there. His experience as Provost of Ohio State, a \$5.4 billion/year enterprise, puts him in a unique position to move the University of Iowa to the next level.

The Regents should not appoint Bruce Harreld. I understand that the novelty of selecting a non-traditional candidate has inherent appeal. But that appeal pales when compared to the manifest risks. This week, the University of Iowa Chapter of the American Association of University Professors (AAUP) sponsored an opinion poll concerning the four candidates for the Presidency of the University of Iowa who recently completed the on-campus portion of the interview process. This release is intended to provide some background on this project and to share a portion of the results.

Purpose

The AAUP recognizes that the ultimate decision for the Presidency of the University of Iowa rests with the state of lowa and its duly appointed representatives, the Board of Regents. At the same time, shared governance is a crucial part of academic leadership, as all four candidates attested in their public forums. Academic leadership cannot be effective without buy-in from all of the stakeholders in the university community, including faculty, students, staff, alumni, and community members.

For this reason, the AAUP initiated this survey project to help obtain a clearer and more objective picture of the views of the University of Iowa stakeholders. In part this was driven by what it perceived to be two key limitations of the process initiated by the Board of Regents and Parker Executive Search. First, the rapid timeline for decision-making meant that the qualitative (free response) comments being collected by Parker would be difficult to summarize and interpret quickly enough, limiting the meaningfulness and utility of their contribution to the discussion. Second, many faculty members and other stakeholders were concerned that these comments were only being collected by a private firm and that consequently there would be no public accountability and the consensus view would be unknown.

Thus, the AAUP conducted an anonymous survey that included rating-scale items along with free-response items to enable a rapid, quantitative synthesis of stakeholders' views. We are sharing the full results with the Faculty Council to assist in their formulation of a recommendation and with the Board of Regents to assist in their decision-making. In the spirit of open governance that has long characterized the University and State of Iowa, we are also sharing a summary of the quantitative results with members of the press and the public.

About the Survey

The survey consisted of 10 questions. It was conducted separately for each candidate, and results were coded by whether the respondent was faculty, staff, student, alumnus, community member or other. Respondents were not asked to compare candidates (consistent with the Board of Regents' request that faculty governance organizations do not provide a "rank order"), but simply to judge each candidate's strengths and weaknesses individually. All responses were anonymous.

Box 1: Questions in the survey. Note phrases in parenthesis were not part of the survey but are used to refer to questions in the presentation of the results.

- 1. This candidate would excel at articulating the University's vision, mission, and values to both internal and external stakeholders (Articulates Vision).
- This candidate has the skill set to oversee a \$3.5 billion institutional budget (including UIHC). (Oversees Budget)
- 3. This candidate would excel at securing external funding support for the University. (Secures External Funding)
- 4. This candidate has demonstrated the ability to lead a complex academic research institution and medical center. (Leads Academic Institution)
- 5. This candidate has the ability to promote a shared vision to address challenges and create opportunities, especially in the areas of student recruitment, research support, finances, and improvements to facilities and technology. (Promotes Shared Vision)
- This candidate could work effectively with elected officials, governmental bodies, and the Board of Regents to advance the mission of the University. (Works with Government)
- This candidate could work effectively with the various constituencies of the University, alumni, Foundation, media, and community at large to advance the mission of the University. (Works with constituencies)
- This candidate could effectively establish trust with University students, staff, and faculty. (Establishes trust with UI community)
- This candidate has the knowledge and intellectual vision to support and further the University of Iowa's excellence in research, teaching, and public engagement. (Enhances Excellence)
- 10. Is this candidate qualified to be President of the University of Iowa? Y/N (Qualified)

The first 9 questions asked participants to respond using a seven point scale, where 1 indicated "strongly disagree", and 7 indicated "strongly agree". All questions were phrased to reflect positive attributes of the candidate (so a higher score is better). Questions were based on the responsibilities and preferred qualifications listed on the University of Iowa President Job Description (http://president.uiowa.edu/ui-presidentsearch/university-jowa-president-job-description). Questions can be seen in Box 1. The final question asked "ls this candidate qualified to be President of the University of Iowa?" and required a simple yes/no response.

In addition, participants were given the option to describe candidate strengths and weaknesses, and to leave other comments in three separate free-response fields. These responses are being shared only with Faculty Council.

A complete graphical and numerical summary of responses to each question is attached below.

This survey – like most online surveys, including that conducted by Parker Executive Search – contains a number of limitations that limit its scientific validity. First, respondents self-selected to provide their views, meaning

that people who are more motivated are more likely to respond and may not be representative of all stakeholders of the University of Iowa. Second, there was no systematic way to get the survey out to all members of the university community, so we relied on word of mouth and flyers handed out at each of the public forums. Third, as with the Parker Executive Search survey, there was no way to prevent people from providing data for the same candidate twice or to ensure that each participant responded to each candidate, without

compromising anonymity, which we judged to be of paramount importance. Despite these limitations, which are characteristic of most online survey research, we had an excellent response (see Table) and are confident that the results of this survey provide a useful snapshot of the views of a large portion of the University community regarding the Presidential candidates for the University of Iowa.





I first want to say thank you for all of your efforts in choosing the next President of the University of Iowa. It was an honor to serve on the search committee as well as to help make the process a success as Faculty Senate President. It has also been a pleasure and a point of pride for me to work with you all in building stronger relationships between the UI faculty and the Board of Regents.

On behalf of the Faculty Senate, I am writing to express some concerns regarding the presidential search. Of course, I would prefer to talk to each of you in person, but that is not feasible at this time.

First, I want to say that there is one aspect of the search process that has not made me proud. Yesterday, at Bruce Harreld's town hall forum, a few of the questions from various members of the UI community were rude and hostile. I spent a lot of time today, along with other shared governance groups, working on a joint statement that has now been sent to our media outlets. I want to share that statement with you now, in the hope that you will understand that this behavior is not representative of our fine university.

Joint Statement from UI Faculty Council, Staff Council, Student Government, and Graduate and Professional Student Government:

"UI faculty, staff, and students appreciate the opportunity for the open exchange of ideas offered by the UI presidential town hall forums. UI shared governance groups regret that while many members of the UI community asked thoughtful questions at Mr. Harreld's town hall forum, some of the questions transformed a vigorous debate into a hostile atmosphere. Many of our constituents were embarrassed by these comments and felt they were not characteristic of the UI community as a whole. Indeed, many of us engaged in respectful dialogue with Mr. Harreld throughout the day. Whatever any of us think of a particular candidate's qualifications to be our next president, we must honor the ideals of civil discourse and the respectful exchange of ideas that are the cornerstones of higher education and this great institution."

Nevertheless, although many of us like Mr. Harreld personally and have been intrigued by him as a candidate, I am sorry to report that the ultimate Faculty Council feedback we submitted to you today shows a clear lack of faculty support. I had genuinely hoped that the faculty would be enthusiastic about all four candidates, but I do not see any way to interpret the faculty's feedback on Mr. Harreld as positive.

Finally, I fear that choosing Mr. Harreld would destroy the goodwill that the Faculty Senate and the Regents have worked so hard to establish. As I hope you know, I have worked tirelessly to encourage openness and trust amongst the university community in this process. There is no doubt that, if Mr. Harreld is chosen, some members of the Faculty Senate would demand a no-confidence vote in the Regents. Whatever the outcome of that vote, it is hard to see how the Regents' relationship with faculty could thrive under such circumstances.

The search process has been very successful in that three outstanding candidates have garnered tremendous support from campus constituencies. The choice of any of these three candidates would instill faculty confidence in our president as well as in the Board of Regents. Again, the Faculty Senate deeply appreciates all of your work on our behalf.





I hope this finds you well. I'm writing to you in response to the election of Bruce Harreld as the President of the University of Iowa. I'm writing to you as someone who grew up in Iowa City, attended the University of Iowa as an undergraduate, went on to attend Brown University for graduate school, and am now a doctoral student at the University of Denver.

I am appalled and ashamed that the lowa Board of Regents has appointed Bruce Harreld as the President of the University of Iowa. I am appalled and ashamed on many levels. Bruce Harreld has little experience with academic administration, and I fear that the undergraduate university I attended—the university I held in such high regard, and often, until now, would encourage people to apply to—is slowly (or rather, with this appointment, quickly) becoming defamed. I will no longer encourage people to apply to the University of Iowa on the undergraduate, graduate or doctoral level.

I am deeply concerned about the corporatization of the University of Iowa, and I am deeply concerned that this appointment will, in fact, "hammer the nail in the coffin" for the University of Iowa's highly regarded academics.

I still receive weekly calls from the University of Iowa Fund asking if I would like to donate money--I've been receiving weekly calls for the four years since I have graduated. Now that I am receiving a generous stipend at a well-funded school, I was indeed planning on donating money to the University of Iowa (as it is the school that allowed me, as a first generation college student from a low income background, to attend an Ivy League school for graduate study, and beyond).

However, now I will not donate to the University of Iowa, and I will not tell those in similar situations as mine (diverse students from lower income backgrounds) that the University of Iowa is an inclusive school to attend. While watching the Q&A forum with Bruce Harreld, I saw two women ask Harreld if he had ever done anything to support those who are not as privileged as him, the "little man." To this he had no response, and moved on quickly to the next question. It's very, very unfortunate; it's also unfortunate that the high school students I have mentored and continue to mentor in Iowa City will not be receiving my encouragement in attending the University of Iowa.



I write to express my concern and disappointment regarding your decision to appoint J. Bruce Harreld as the 21st president of the University of Iowa.

The values I learned during seven years and two degrees at the University of Iowa are not reflected in this decision. First, during my time at Iowa, professors, fellow students, and staff members instilled in me a firm sense of integrity. Your decision to completely ignore Mr. Harreld's misrepresentation on his resume severely undermines this tradition. Second, while at lowa, I viewed faculty, staff, and students value collaboration and team work. I am forced to conclude you selected Mr. Harreld precisely because he had such little faculty support. 




