My name is Robert W. Hall. I am an attorney that has practiced law in Harlan, Iowa for the last 38 ½ years. I received my bachelor of business administration degree from the University of Iowa in 1973. I graduated from Creighton Law School in 1976. I feel that I am well qualified to serve for the reasons as I hereinafter set forth.

I have years of experience serving on public agencies and being directly involved in the hiring process of chief executive officers. I was elected to the Board of Trustees of Shelby County Myrtue Memorial Hospital in Harlan, Iowa and served from 1991 through 2008. Iowa Public Television is thriving and blossoming under Molly's leadership today.

Whether serving on the local county public health hospital board or Iowa Public Television, I thoroughly understand the process that a public agency must go through in selecting a new president. I understand nuances of open meeting law

and public record law as they apply to public agencies. I would also like to think that I have the savvy to understand and recognize the talents of prospective chief executive officer candidates.

The other major reason I think you should consider my application is that I have a strong passion for the University of Iowa. My wife and I are both University of Iowa graduates. My three children are University of Iowa graduates. My two son-in-laws and one daughter-in-law are University of Iowa graduates. Between eight of us we have eleven degrees from the University of Iowa. Also, my wife, my daughter and one of my son-in-laws have their varsity letters for participation in athletics at the University of Iowa. I want to see University of Iowa succeed and blossom. It is very important to me that the Board of Regents selects the right candidate to lead the University of Iowa into the twenty-first century.


